- 11. You will not post any content that advertises or promotes any services or web links to other sites.
- 12. You will not post any content that would cause LearnInvestment.Online to breach any regulatory requirement, whether that requirement is in the United Kingdom, United States of America, European Union or elsewhere.

- 13. We will determine in our absolute discretion whether there has been a breach of the Code of Conduct.
